his will be my last message as Chairman of the Centre for Fathering (CFF). In the blink of an eye, it has been 20 years since we were established and more than a decade since I have been serving on the board.

Over the past two decades, we have impacted and equipped a new generation of fathers to be more engaged and active. We have also helped change paternity leave laws and made it cool to be a Dad! Our grand vision and ultimate mission is still to eradicate fatherlessness in Singapore and that will continue to be our focus.

Each year, we conduct over 200 programmes in schools, prisons, communities, religious organisations and companies and reach out to over 4.7 million fathers and family members through campaigns such as Celebrating Fathers, Back to School with Dad and Eat With Your Family Day. But this is only the tip of the iceberg.

Since I joined the board in 2009 and later assumed the role as Chairman, there are many moments which have made us proud.

Firstly, we marked our 10th anniversary in 2011 with a fundraising gala dinner graced by President SR Nathan as our Guest of Honour. In 2013, we designed and launched a new logo for CFF to inspire and galvanise a younger generation of fathers and in 2014, we built DADs Adventure Hub - a multi-purpose all-weather facility to train fathers with their children which was opened by Mr Tan Chuan-Jin. I then felt we needed a unifying call to rally like-minded people and organisations to ignite our cause nationwide. I approached the Ministry of Social and Family Development to let us helm DADs for Life and I am glad they found us worthy and agreed. Since 2015, CFF has been the driving force behind the DADs for Life movement.

Having established our role in empowering fathers, CFF and DADs for Life partnered with a group of mother volunteers to launch MUMs for

Life on Mother's Day 2019 to help us dovetail with women in their multiple roles as mother, wife and daughter to complement the work of DADs for Life.

Recently, we planned to celebrate our 20th Anniversary in 2020 but this has to be postponed to next year due to Covid-19. We look forward to celebrating this special milestone with you, our esteemed guests, to thank you for your generous support in helping us raise over \$1M. This occasion will be graced by President Halimah Yacob as Guest of Honour. At the same time, President Halimah will also be presenting our inaugural Great Companies for Dads Award as we pivot our next lap's focus to work with companies to institute good family practices for parents.

Let me end with a quote by John C. Maxwell: "A leader's lasting value is measured by succession". It gives me immense satisfaction to announce that in my final act of duty, we have identified an excellent successor. I will be handling over the chairmanship of this organisation, after our 20th Anniversary celebrations next year, to a fine man and an outstanding father – Keith Magnus.

Keith, who is younger than me, will have a better grasp of the needs of younger fathers. More importantly, he is an honourable man who possesses strong passion for the cause and exemplifies great family values and ethos. We could not have found a better person to helm CFF and take it to the next level.

Thank you all for your sterling support and encouragement over the years. Remember, it is not about us but you and CFF working together to fulfil this worthy cause. Your continued support will enable us to build stronger families.

My best wishes to the CFF board, management team, supporters and volunteers as they work together to fulfil the ultimate goal of eradicating fatherlessness in Singapore. Cheers!

CEO'S MESSAGE





2020 HIGHLIGHTS



CELEBRATING FATHERS 2020 GOES ONLINE

In light of the Covid-19 situation in Singapore, the Celebrating Fathers movement took place entirely online – featuring a campaign to appreciate Dads for everything they are doing for their families and our community, especially how they engage their children and help them thrive in this challenging season.

Themed Voices of Children, Celebrating Fathers 2020 encouraged children to show appreciation to Dads as they continue to do all the things that matter for their families and our community. The campaign aimed to encourage fathers through the voices of their children, and with support from their spouses, to be the best father and husband they can be.

As a show of appreciation for Dads, Mums and children were invited to contribute messages, photos or videos with a Father's Day message for Dads on Instagram hashtag with #THANKYOUDADSG2020. The first 2000 submissions received a Celebrating Fathers Family Pack in return. The Celebrating Fathers Family Pack contained exclusive items including materials for the Design A Tee for Dad contest with prizes up to \$200 to be won. This year's campaign ran from June 8 to July 11.

Initiated in 2016, the Celebrating Fathers movement seeks to raise awareness of the importance of active fathering with a line-up of exciting activities celebrating Father's Day each year. The Celebrating Fathers 2020 campaign is jointly organised by Centre for Fathering, DADs for Life, Families for Life and Mediacorp, in support of the Made For Families initiative.

A Day With Dad was one of the main highlights of Celebrating Fathers 2020. It featured a series of online father-child bonding activities on Facebook conducted by Centre for Fathering and several partners. These included cooking adventures by a DADs for Life volunteer; craft sessions where fathers and children can create a faux stained glass, a disco ball that reflects light and a robotic arm as well as a music and movement workshop with instruments made of things you find at home! The online sessions took place on the DADs for Life Facebook page.

2020 HIGHLIGHTS

EAT WITH YOUR FAMILY DAY DRAWS PARTICIPATION OF OVER 600 ORGANISATIONS AMIDST COVID-19



Despite the more challenging times of the Covid-19 season, the Eat With Your Family Day (EWYFD) initiative has drawn the participation of over 600 such City organisations as Developments Ltd, Etiga Insurance Pte Ltd and Eu Yan Sang International Ltd who encouraged their employees to end work earlier and gather with their families for meals in 2020.

During this time. most organisations were still in a work-from-home mode and employees often grappled with the blurred boundaries of work and life, at times working beyond normal working hours although they were at home. To encourage employees to be present for their families, and bond over meals and activities, the organisers of EWYFD tied-up special deals with over 50 merchant partners for the EWYFDs in September and November to offer food, retail and fun options for family activities.

During EWYFD on 4 September 2020, the organisers of EWYFD worked with over 40 organisations to plan a special programme for their employees. The 150 families nominated by their organisations received a family meal delivered to their homes and participated in a photo contest and movie trivia to win prizes and goodie bags. For both events in September and November, special movie screenings of "Happy Feet 2" and "Despicable Me 2" were also broadcasted on Mediacorp Channel 5 so families could bond over movie time. In addition, the Centre for Fathering offered complimentary online fathering and parenting workshops to further strengthen family bonding.

Mr Tan Chuan-Jin, Speaker of Parliament and Patron for Centre for Fathering, DADs for Life and MUMs for Life said, "Family-friendly initiatives such as Eat With Your Family Day may seem only beneficial to employees but this practice can benefit the company in the long run. Organisations who put their employees first by helping them prioritise their families tend to have employees who are more productive and committed. As such, I would like to encourage companies to embrace EWYFD as part of their efforts to nurture a family-friendly work culture."

2020 HIGHLIGHTS

BUILDING STRONGER FATHER-CHILD BONDING IN PRISON

The Centre for Fathering and DADs for Life have been partnering Singapore Prison Service to organise fathering workshops and father-child bonding programmes for incarcerated fathers and their children. On 6 November 2020, several incarcerated fathers and their children took part in an online Children's Day celebration over Zoom where the Dads read books to their children and played games with them. These Dads also surprised the children with hand-made cards.

Minister of State for Home Affairs and National Development, Associate Professor Dr Muhammad Faishal Ibrahim, who witnessed the session at the Prison Link Center, commented that the absence of a father will leave an impact on the child. As such, the Singapore Prison Service is working with community partners to provide that connection and at the same time provide support to these children. CFF's prison outreach programmes help incarcerated fathers build stronger relationships with their children and minimise the negative impact of their absence on their children's lives while they are in prison. Since 2017, CFF has reached out to and supported more than 1,000 incarcerated fathers and fathers of underprivileged families.






INCOME & EXPENDITURE (\$'000)







FUNDRAISING

THE YEAR AHEAD

To mark the 20th anniversary of Centre for Fathering, fundraising efforts were centred on the Centre for Fathering 20th Anniversary Gala Dinner. The event, originally slated for March 6, 2020, was postponed to 2021 due to Covid-19. As a result, only \$401,600 out of \$1M target was raised.

The Centre for Fathering will also tap on national initiatives such as Celebrating Fathers, Eat With Your Family Day and the Malay Muslim Fathering Month to garner support and awareness for retail-giving and donation. Funds raised in 2020 will go towards the following areas delivering programmes for:

Incarcerated fathers

Families of children with special needs

Marginalised families in various ethnic communities


